- 2. The report was given for permits issued and revenue. There were 16 permits issued for December with a total revenue of \$470,183.90.

- 4. An update was given on the large ongoing community projects within the Sun City district. Banner Boswell Hospital has received their Certificate of Occupancy. The Royal Oaks expansion project is currently ongoing. The Ridgeview project is underway with 125 lots; sprinkler permits will be provided to the 125 homes by the Department.
